

Sanger Memorial RV Park COVID-19 Camper Safety Compliance Checklist



Overnight Camping Access

- limited to self-contained units, including RVs or trailers that have a water supply, holding tanks and personal washroom facilities.
- Occupants of a campsite must be from the same extended household bubble.

Health Screening

Do you or anyone in your camping party have any of the following **new or worsening** symptoms today? *Only tick box if the symptoms are not normal, not related to a known underlying health problem, or if your symptoms are worse than normal.*

- Fever (or signs of a fever, including chills, sweats, muscle aches, lightheadedness)
- Cough not to enter the campground if symptomatic
- Headache
- Sore throat
- Painful swallowing
- Runny nose
- Diarrhea
- Loss of sense of smell or taste
- Unexplained loss of appetite
- Have you travelled outside of NL in the last 14 days?
- Have you had close contact* with a person who has recently traveled outside of NL **AND** has been sick or ill in the past 14 days?
- Have you had close contact* with a person who has been confirmed or suspected to be a case of COVID-19 within the past 14 days?

If you ticked any of the above health screening boxes or if you start to have symptoms of COVID-19 you are not to enter the campground, remain at home. Visit gov.nl.ca/covid19 for more information or call 811

Mitigating Risks While Visiting

- Maintain a distance of at least 6 feet away from all other campers unless they are part of the same bubble.
- Maintain a distance of at least 6 feet away from all Sanger Memorial RV Park Team Members
- Cash will not be accepted. Debit or credit card payment will only be accepted.
- Campers will not be permitted to enter the main registration kiosk. Upon arrival registration or check out will be contactless – payment will be made at the second kiosk window.
- The following facilities are closed: Comfort Station (Washrooms & Showers), Social Centre, recreational Facilities & Laundromat

Practice Preventive Measures

Everyone has a role to play in reducing the spread of COVID-19

- Wash hands or use an alcohol-based hand sanitizer frequently
- Practice proper cough and sneeze etiquette. Cover your mouth and nose with your arm when coughing and sneezing and immediately dispose of used tissues in the trash.

- If you encounter campers not maintaining the 6ft social distancing requirement, please remember that they may be in the same bubble. If someone infringes on your 6ft rule, please do-escalate any confrontational situations and if needed report the situation to the office via email or phone.
